III. Follow-up on Disability and Accessibility

- a. Mike Bath, Director of Public Safety and Police Services
 Bath reiterated some of the things being done on campus regarding accessibility
 and snow removal (PCOD minutes 2/16/18). He encouraged everyone to let them
 (Public Safety/Facilities) know when things aren't right.
 - Bath also discussed the WildCat Shuttle service. Once again, usage is down. There are discussions regarding alternatives, such as a door-to-door service or proposed off-campus runs such as to Wal-Mart or Meijer.
 - Bath felt that having someone who was differently-abled and/or who had knowledge as a representative on the Master Planning Committee would be of value.

Motion: The President's Committee on Diversity recommends adding a member to the Campus Master Planning Committee who is differently-abled and/or who has significant knowledge to ensure proper representation of those with special needs.

- b. Jennifer Gorton, Coordinator of Disability Services
 - Gorton discussed the accommodations flow-chart that is used to assist those who need assistance. She would send PCOD a copy for their perusal.
 - Hightower stated that he had worked with Disability Services in his role as professor and stated that the process works well and was thankful for this service.
 - Gorton also discussed the WildCat Shuttle service and how ridership among those who use Disability Services is extremely low. She shared information from a survey the department had conducted. EXHIBIT A
 - She also discussed assistance animals and the different types. These include therapy, service and assistance animals.
